This category excludes PhD Students, Administrative Staff, Technical Staff, Laboratory technicians, Research Assistants, Librarians, Adjunct Professors, Visiting Scholars.

-B1.1.2 Of which are teaching only

refers to the headcount number of full-time academic staff who are assigned teaching responsibilities only during the reporting year. This category may include Instructors, Lectures, Readers, or equivalent academic positions. This category excludes PhD Students, Administrative Staff, Technical Staff, Laboratory technicians, Research Assistants, Librarians, Adjunct Professors, Visiting Scholars.

-B1.1.3 Of which are research only

refers to the headcount number of full-time academic staff who are assigned research responsibilities only during the reporting year. This category may include Research Professors, Research Associate Professors, Research Assistant Professors, Research Fellows, Research Associates, Research Scientists, Postdoctoral Fellows, or equivalent academic positions. This category excludes PhD Students, Administrative Staff, Technical Staff, Laboratory technicians, Research Assistants, Librarians, Adjunct Professors, Visiting Scholars.

-B1.1.4 Of which are international staff

refers to the headcount number of full-time academic staff who do not hold the nationality of the country where the institution is located.

refers to the headcount number of part-time academic staff with teaching or research responsibilities employed by the institution during the reporting year. refers to the number of full-time students undertaking degree programs at bachelor's or its equivalent level during the reporting year. Such programs normally require three to four years (or the equivalent) of study.

-C1.1.2 Of which are enrolled at master's level

refers to the number of full-time students undertaking degree programs at master's or its equivalent level during the reporting year. This category includes both academic/research and professional master's programs.

-C1.1.3 Of which are enrolled at doctoral level

refers to the number of full-time students undertaking degree programs at doctoral or its equivalent level during the reporting year. This category includes both academic/research and professional doctoral programs.

C2. Part-time Degree Students

-C2.1 Total Number (Headcount) of Part-time Degree Students

refers to the number of degree students formally enrolled at the institution during the reporting year who are registered under part-time study status, counted by head. Part-time enrolled students are those who (1) hold official student registration status and have completed enrollment procedures for the reporting year, (2) pursue their degree programs under part-time study arrangements, and (3) don't meet the institution's defined workload or credit threshold for full-time study, or are otherwise classified as part-time according to institutional regulations

-C2.1.1 Of which are enrolled at bachelor's level

refers to the number of part-time students undertaking degree programs at bachelor's or its equivalent level during the reporting year.

-C2.1.2 Of which are enrolled at master's level

refers to the number of part-time students undertaking degree programs at master's or its equivalent level during the reporting year. This category includes both academic/research and professional master's programs.

-C2.1.3 Of which are enrolled at doctoral level

refers to the number of part-time students undertaking degree programs at doctoral or its equivalent level during the reporting year. This category includes both academic/research and professional doctoral programs.

C3. Full-time International Degree Students

-C3.1 Total Number (Headcount) of Full-time International Degree Students

refers to the total number of full-time degree students who do not hold the nationality of the country where the institution is located during the reporting year. International student status is determined by nationality. Students participating solely in short-term exchange programs without formal degree-seeking registration are excluded, unless otherwise defined by institutional regulations.

-C3.1.1 Of which are enrolled at bachelor's level

refers to the number of full-time students who do not hold the nationality of the country where the institution is located and who are undertaking degree programs at bachelor's or its equivalent level during the reporting year.

-C3.1.2 Of which are enrolled at master's level

refers to the number of full-time students who do not hold the nationality of the country where the institution is located and who are undertaking degree programs at master's or its equivalent level during the reporting year.

-C3.1.3 Of which are enrolled at doctoral level

refers to the number of full-time students who do not hold the nationality of the country where the institution is located and who are undertaking degree programs at doctoral or its equivalent level during the reporting year.

-C4.1 Total Number (Headcount) of Part-time International Degree Students

refers to the total number of part-time degree students who do not hold the nationality of the country where the institution is located during the reporting year. International student status is determined by nationality. Students participating solely in short-term exchange programs without formal degree-seeking registration are excluded, unless otherwise defined by institutional regulations.

-C4.1.1 Of which are enrolled at bachelor's level

refers to the number of part-time students who do not hold the nationality of the country where the institution is located and who are undertaking degree programs at bachelor's or its equivalent level during the reporting year.

-C4.1.2 Of which are enrolled at master's level

refers to the number of part-time students who do not hold the nationality of the country where the institution is located and who are undertaking degree programs at master's or its equivalent level during the reporting year.

-C4.1.3 Of which are enrolled at doctoral level

D1. Institutional Income

-D1.1.1 Of which was derived from governmental appropriations

refers to the governmental appropriations provided to the institution by national or local government authorities, including central government funding, local government funding, earmarked appropriations, and non-research project-based appropriations.

-D1.1.2 Of which was derived from student tuition and fees

refers to the charges levied by the institution for educational services provided to students or other learners, including tuition fees for degree programs at the undergraduate, master's, and doctoral levels; fees for continuing education and vocational training; admission or application fees; examination fees; and other student-related charges.

-D1.1.3 Of which was derived from research activities

refers to the income generated by the institution from research activities and related support activities, including governmental research grants, industry-sponsored research funding, revenues from research contracts, technical service fees, and other research-related income.

-D1.1.4 Of which was derived from donations and endowments

refers to funds received by the institution or institutional endowment from individuals, corporations, foundations, alumni organizations, or other external entities, with no restrictions or only limited restrictions on their use. This excludes revenues from investments of endowment funds.

-D1.1.5 Of which was derived from self-operating activities and investments

refers to the revenues generated by the institution through self-operating activities, service provision, investments (including investments of endowment funds), and the management or utilization of institutional assets. This category includes revenue from auxiliary services (housing, dining, and student health services) and intellectual property licensing (royalties, trademarks and patents), as well as returns on assets such as interest, dividends and rent.
